Saturday, July 18th, 2026

Entries: 8:00 – 8:45 am and 15 min after show 1.

9:00 am: Rally trial 1 begins. Rally trial 2 will begin 1 hour after trial 1.

9:30 am: Conformation Show 1 judging begins. Show 2 will begin 1 hour after trial.

Conformation and Obedience Entries: 8:00 – 8:30 am and 15 min after show 1.

8:30 am: Obedience judging begins. Trial 2 will start 45 min after trial 1.

Attention: Order for Trial 2 will be BN, Utility, Open, Novice

9:30 am: Conformation Show 1 begins. Show 2 begins 45 min after show 1.

*Judging order for all conformation shows: Altered, Non-Regular, Juniors, Intact

No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

Attention! All Regular Intact and Altered Class Entries

All entries in Regular Conformation Classes must be at least 6 months of age or older on the day of the show and be ASCA registered. You will be asked to show proof of registration (phone photo is acceptable).

Regular Conformation Classes offered (all divided by sex): 6-9 mo, 9-12 mo, 12-15 mo, 15-18 mo, Novice, American Bred, Bred by Exhibitor, Open Blue Merle, Open Red Merle, Open Black, Open Red, Best of Breed

Non Regular Conformation Classes offered (divided by color and sex): 2-4 puppy, 4-6 puppy, Best Puppy.

Veterans 7-10, Veterans 10 and over, Best Veteran

Additional Non Reg Saturday PM only: Movement, Michigan Bred, Brace, Best Head

Regular Junior Showmanship: 8-12 Novice Junior, 13-17 Novice Junior, 8-12 Open Senior, 13-17 Open Senior. **Non Regular Junior Showmanship:** Pee Wee 3-5 yrs, Sub Junior 6-7 yrs.

Rally Trial Run Order and Classes Offered: Masters A/B/C, Excellent A/B/C, Advanced A/B/B, Novice A/B/C. Please, remember to include jump heights. Juniors, please remember to complete your junior entry form.

Sunday, July 19th, 2026: 8:30 am Obedience Trial 1 judging begins. Obedience Trial 2 will begin 45 min after Trial 1.

Class Order for Trial 1: Utility, Open, Novice, Beg Novice.

Class Order for Trial 2: Beg Novice, Utility, Open, Novice

Utility and Open classes will run in jump height order. Please, remember to include jump heights on Utility and Open entries.

Junior Obedience exhibitors, please remember to note "JUNIOR" on the entry form!

All-Breed Obedience Trial Classes Offered: Utility A & B, Open CDX A & B, Open ODX A & B, Novice A/B/C, Beg Novice A & B.

NOTE TO RALLY & OBEDIENCE COMPETITORS: All ASCA rules will be followed. This is not a match! All dogs will be competing for ASCA obedience titles and must be ASCA registered. Each entry form must include the ASCA registration number and be completely filled-out. If your dog has earned titles through another registry, but not ASCA, your dog will be required to begin in Novice.

Tracking fees for Non-ASCA dogs: All non-ASCA registered dogs will be required to have an ASCA tracking number. This is a one-time fee of \$20 per dog. At the time of applying for the tracking number, the owner must also have an ASCA membership (Service member fee \$20). Membership does not need to be maintained in subsequent years. You may apply for a tracking number at the show, if your dog needs one. For more information about ASCA programs and rules, visit the ASCA website www.asca.org.
